TERMS AND CONDITIONS

1. Information on how to enter and prize(s) form part of these Terms and Conditions. Participation in this **'Win a Share of \$2,500 Coles Gift Cards this Christmas'** Promotion ("**Promotion**") is deemed acceptance of these Terms and Conditions.
2. The promoter is Chevron Renaissance Asia Pacific Shopping Centre Pty Ltd ACN 603 495 030 (in its capacity as trustee for the Chevron Renaissance Shopping Centre Unit Trust) care of Centre Management at 3240 Surfers Paradise Boulevard, Surfers Paradise, Queensland 4217 Australia ("**Promoter**").

PROMOTION PERIOD

3. Promotion commences at 9:00am on Friday 18 November 2020 and final entries close at 3:00pm on Friday 22 December 2023 ("**Promotion Period**"). All times throughout the Terms and Conditions will be based on AEST and based on QLD local time. Entries received outside of the Promotion Period will not be eligible

ELIGIBILITY

4. To be eligible to enter the Promotion (and so be an "**Entrant**") an individual must be aged 18 years or older and be a Queensland resident.
5. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers in Chevron Renaissance Shopping Centre ("**Participating Centre**") or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

ELIGIBLE TRANSACTION

6. An "**Eligible Transaction**" is a purchase:
 - (a) of any goods or services, excluding:
 - (i) tobacco products;
 - (ii) gambling products;
 - (iii) gift cards;
 - (iv) deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or
 - (v) telephone, internet or mobile phone calling cards or credit cards;
 - (b) for the amount of \$20.00 or more, in a single transaction, at any Participating Retailer (defined below);
 - (c) made during the Promotion Period.
7. A purchase of an item on lay-by will be deemed to be one Eligible Transaction only upon completion of the lay-by, if the purchase otherwise would qualify as an Eligible Transaction. To remove any doubt, the final lay-by instalment payment must be made during the Promotion Period.

8. A “**Participating Retailer**” refers to retail stores in the Chevron Renaissance Shopping Centre.
9. An Eligible Transaction must be evidenced by a “**Valid Receipt**” being an original official receipt/ tax invoice from a Participating Retailer that is clearly marked with the date of purchase, the amount of the purchase and the store or business trading name.
10. Multiple entries are permitted per person, however, each entry must be submitted separately and in accordance with entry requirements. For clarity, a maximum of one (1) entry is permitted per person when entering using Option 2 (outlined below) as a method of entry. Only one (1) Code per entry is permitted. The same Code cannot be used more than once and unrecognised Codes will be deemed invalid.

HOW TO ENTER

11. To be eligible to enter, Entrants must undertake one or both of the following options:

Option 1

12. An Entrant will be entitled to one of the Promoter’s official entry forms (“**Entry Form**”) for each Eligible Transaction evidenced by a Valid Receipt. For the avoidance of doubt, an individual will be entitled to one (1) Entry Form for each Valid Receipt regardless of the amount spent in excess of \$20 e.g. where a Valid Receipt from a Participating Retailer evidences an Eligible Transaction totaling \$45.00, the individual will only be entitled to one (1) Entry Form.
13. To obtain an Entry Form, an Entrant must obtain or present their Valid Receipt to a Participating Retailer during the Promotion Period.
14. Participating Retailers have the right to refuse to accept a Valid Receipt and to provide an Entry Form if they believe that an individual who is presenting a Valid Receipt was not the individual who entered into the Eligible Transaction evidenced by the Valid Receipt.
15. Each Entrant must then complete the Entry Form in full and lodge the completed Entry Form in the Promoter’s official entry barrel or similar device (“**Entry Barrel**”) located near Coles Supermarket in the Participating Centre during the Promotion Period

Option 2

16. The Promoter will be distributing promotional flyers by way of letterbox drop in the local area surrounding the Participating Centre (“**Flyer**”). Each promotional Flyer will contain a unique code (“**Code**”). To enter, individuals that receive a Flyer with a Code can enter the Promotion by visiting <http://chevronrenaissanceshoppingcentre.com.au> Christmas Promotion page following the prompts to the Promotion entry page, inputting the requested details including their Code and submitting the fully completed online entry form during the Promotional Period.
17. It is a condition of entering the Promotion (either Option 1 or Option 2) that Entrants agree for their personal information to be added to the Chevron Renaissance Shopping Centre database and to be used in accordance with the purposes set out in these Terms and Conditions.
18. On lodgment of a Valid Entry in accordance with these Terms and Conditions, an Entrant will be eligible for the relevant prize draw/s (each a “**Prize Draw**”).
19. The Promoter reserves the right, at any time, to verify the validity of Entrants and may disqualify any Entrant who fails to comply with these Terms and Conditions, manipulates the participation process, acts unfairly, dishonestly or unlawfully or who tries to influence the Promotion by disruption, harassment or annoyance of employees or representatives of the Promoter or other Entrants.

PRIZES

20. The total available Prize pool for the Promotion is (at prices applicable as at November 2023 and subject to variation) AUD \$2,500.00, comprising of the following:
 - 5 x \$500 Coles Supermarket Gift Card (each a “Prize”).
21. The Coles Supermarket Gift Card must be redeemed at Coles Supermarket for goods and services provided by that retailer. The Prize has a serial number and will be valid for use for a period of 12 months from the date of issue detailed on the card. The Prize must be redeemed by this date or it will expire and be forfeited.
22. The Prize may only be used to make purchases up to the value stated on the card. If an individual wishes to make a purchase for an amount exceeding this value, the individual must pay the excess using another payment method accepted by Coles Supermarket.
23. Any complaints about goods or services purchased with the Prize must be resolved directly with Coles Supermarket.
24. Winners (defined below) are responsible for the use and safety of their Prize. The Promoter is not liable for a lost or stolen Coles Supermarket Gift Card and no replacement card will be issued.

The first valid entry drawn in each Prize Draw for each Entry Period will each win a Prize and be deemed a winner (“Winner”). difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) subject to any written directions from a regulatory authority to modify, to disqualify any Entrant; or (b) to modify, suspend, terminate or cancel the Promotion, as appropriate.
